I request urgent protection and monitoring regarding severe institutional violence suffered in Santa Fe, Argentina, between Nov 2–11, 2025. Police officers and municipal/provincial officials committed torture, threats, unlawful detention, and a direct attempted homicide against me.

PRESS RELEASE – HUMAN RIGHTS CASE (FOR MEDIA)

PRESS RELEASE – ATTEMPTED HOMICIDE AND TORTURE BY STATE AGENTS – SANTA FE, ARGENTINA

Between November 2 and November 11, 2025, a resident of Santa Fe was subjected to torture, physical assaults, threats, unlawful detention, and an attempted homicide by police officers and municipal/provincial officials across Granadero Baigorria, Capitán Bermúdez, and Fray Luis Beltrán.

The evidence has been publicly preserved at www.seralavida.com. The case has been submitted to PROCUVIN, PIA, the National Human Rights Secretariat, and international bodies (CIDH, UN).

An international call for oversight and protection is being made due to the risk of coverup and continued threats.

EXPANDED CHRONOLOGICAL TESTIMONY

FULL CHRONOLOGICAL TESTIMONY:

Nov 2, 2025 – First threats and physical assaults by police and officials in Granadero Baigorria.

Nov 3 – Escalation of coordinated harassment, surveillance, and intimidation.

Nov 4 – Confrontation involving multiple officials; threats to life explicitly communicated.

Nov 5 – Violent assault and forced immobilization; pattern indicates organized action.

Nov 6 – Torture and unlawful deprivation of liberty.

Nov 7–10 – Worsening persecution across three cities: Baigorria, Bermúdez, Beltrán.

Nov 11 – Attempted homicide in public space; victim escapes and secures evidence.
